This month, MOAA will send teams of state council leaders to Washington, D.C., to meet with their legislators at the Capitol as part of their Advocacy in Action (AiA) efforts. Chapter Member Steve Bond will be part of the Florida Council of Chapters delegation. This year's two primary goals are: increase basic allowance for housing (BAH) to 100%, restoring the BAH reductions from 2015-2019; and to reverse the TRICARE pharmacy cuts. Please visit the MOAA website to get more information on these topics to be better informed. Reach out to Steve and to our Chapter Legislative Affairs Team, John McMahon and Tim Pishdad. MOAA considers these endeavors as supporting recruiting and retention efforts by ensuring the promises made to our service members are kept.

To support the MOAA's Advocacy in Action (AiA) efforts, please reach out to your elected officials and ensure they are aware of your concerns. The easiest way to stay abreast of the pending legislation of interest is to visit the Legislative Action Center (<https://moaa.quorum.us/>) on MOAA's webpage. Here you can find draft e-mails to send to your Senators and Congressman. I urge you to do a little homework before you hit send as sometimes the list of cosponsors will change and the letter's don't get updated immediately. You can lose creditability by asking your representatives to sponsor legislation they are already sponsoring. In this instance we need to thank them for their support and let them know we notice and appreciate what they are doing for us.

We will be presenting the MOAA Medals and Grants to some very deserving cadets at the April Luncheon. These are the future leaders of their organizations and are outstanding individuals. The Hardman Family Foundation donated \$3,000 to support this program, this is the second year they donated to this program. We are very grateful to them and to Amir "Butch" Pishdad Jr. who spoke at an event they sponsored in Mexico. We also appreciate our other donors and the people who purchased 50/50 tickets though out the year as the proceeds go to support the MOAA Medal Grant program. The Good Deeds Foundation has stepped up to support and lead this effort. Their help and leadership are greatly appreciated.

## LEGISLATIVE AFFAIRS

### The Budget Process Kicks Off

President Biden released his Fiscal Year (FY2024) Budget request in early March which totaled a whopping \$6.89 Trillion to begin the annual budget cycle for which the Congress is responsible. This budget proposal has been touted for reducing the National debt by \$3 Trillion and for raising taxes by almost \$4.7 Trillion over 10 years, a significant bump up to revenue. However, key Republicans in the House and Senate have reportedly dubbed this proposal as dead on arrival and “an unserious proposal that is a road map for fiscal ruin” (Senator Grassley (R-IA) and top Republican on the Budget Committee). Speaker McCarthy (R-CA) noted “we must cut wasteful government spending” and “our debt is one of the greatest threats to America” while asserting “Washington has a spending problem, not a revenue problem”. Truth in lending is we have both (a spending and a revenue problem) that both parties need to reconcile with in order to put our financial future into some semblance of stability, credibility and reliability. House Republicans have committed to publishing their own budget proposal in early April so the jury is out on the details and implications of their approach.

A deeper look into what’s in the President’s budget proposal provides some interesting insight into his priorities as he purportedly plans to run for re-election in 2024. The best moniker one can give his budget proposal would probably be a good Bernie Sanders budget that spends way more than it should on new and growing social programs while attempting to cover the spending growth with new taxes that mirror what was ultimately rejected by a Democratically controlled Congress last year. Selected highlights from the Spending and Revenue/Taxes sides of the equation follow along with some takeaways from MOAA Headquarters’ perspective.

With a projected deficit of \$1.8 Trillion in FY24, spending grows to 25.2% of GDP (compared to a 50 year average of 21%) which includes rising interest costs on the federal debt and new and increased entitlements such as universal pre-K and free community college (\$300 B), child care (\$400B), paid family leave (\$325B), elder and disabled home care (\$150B), expanded health care assistance for Obamacare (\$400B) and housing (\$100B). Proposed Defense outlays are \$842B, a 3.2% increase but with sector inflation running at 5%, this is an actual cut! It includes \$7B more for Ukraine support (to be further supplemented throughout the year) and \$23.6B for modernizing our nuclear weapons triad by the Energy Department.

The budget proposal allocates \$144B (11.5% increase) Health and Human Services for negotiating drug prices and to expand permanent subsidies for Obamacare, adds \$11B to eliminate hepatitis C in 5 years, and allocates \$1.4B (10% increase) to the Social Security Administration to improve customer service and add staff to process disability claims. It also increases certain taxes (see below) to extend Medicare solvency and Social Security long-term viability. It stipulates \$25B for Customs Enforcement, Border Control and Immigration Enforcement including the

hiring of 350 more agents and 460 processing assistants, a new \$4.7B contingency fund to deal with migrant surges, \$1.5B for the backlog in immigration court cases, and \$7.3B for settling illegal unaccompanied minors. It proposes \$4.5B for clean energy workforce and infrastructure projects, \$16.5B for climate science and clean energy research, and \$23B for climate resilience against floods, wildfires and storms. It also includes \$19.4B over 10 years to help local police departments hire more officers and \$5B for community programs to fight violence, and \$17.8B for the Justice Department including \$2B to combat gun violence. It increases funding to the Transportation Department for increasing funds to states for roads, bridges and transit systems, including a network of charging stations for electric vehicles and a modest increase for railroad safety; it grants \$7.5B to Amtrak and boosts FAA modernization programs. Finally, there is a \$27.2B (7% increase) allocation to NASA for the Artemis lunar mission and space tug to retire the space station in 2030.

On the revenue side, President Biden has resurrected some old proposals. These include: a new wealth tax (25% minimum on Americans with more than \$100M in wealth); hikes in the personal income and capital gains taxes (tax capital gains as ordinary income for those making more than \$1M and raise the top rate from 37% to 39.6% on personal income above \$400K); extends the 3.8% surtax currently applied to investment income for couples making more than \$250K to business income; and increases the top Medicare payroll rate to 5% for those earning more than \$400K. The budget proposes corporate rate increases to 28% from 21%, and the minimum on foreign earnings of US multinational corporations to 21% from 10.5%. There is also a four-fold tax increase to 1% on corporate stock buybacks as well as several other nuanced tax changes that raise hundreds of billions more in tax revenue. Raising all these taxes is one thing if they are intended to bring down the deficits and the national debt; but such tax increases make no sense if they are purely intended to increase spending on hard-to-justify social programs. Close scrutiny by the Congress is warranted.

For Military personnel, MOAA reports a 5.2% pay raise for uniformed servicemembers and the federal civilian workforce as well; military end strength is increased by 12,335 personnel. There is funding to expand community based child care fee assistance and address child care capacities. The budget proposes \$1.45B to subsidize commissary operations, a \$27M increase. For Veterans, the budget increases to \$325B, a 5% increase including \$142B for veterans’ health care and \$183B to cover compensation and pensions, benefits, insurance and indemnities. There are also provisions for implementing the toxic exposure reforms approved last year, and to modernize and fully fund the VA, expand servicemembers’ consumer protections and help reserve component members access their full benefits. There is also \$12.1B allocated to sustain readiness, resilience and capability for the US Coast Guard. The next step in the Budget process will involve hearings by the Congress for Department Heads to justify their requests.



## FINANCIAL LITERACY

### SECURE 2.0 Takeaways, Part 2

Last month, we started examining the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, which became law in December 2022. This month, we continue to look at some of those retirement and tax-related provisions:

\* Employers oftentimes match the contributions that their employees make to their retirement plans, typically in the range of 3-6%. These employer match dollars for retirement plan contributions can now go into Roth 401(k)s, 403(b)s or 457s. Beforehand, all of any employer match dollars was mandated to go into pre-tax (not post-tax like a Roth part); on the other hand, the employee contributions can continue to go into either pre-tax or post-tax, depending on what the retirement plan of any particular company offers and what option the employee chooses. These match dollars will be immediately vested. One important impact of this provision: the employee will foot the tax bill for this new employer match contribution to Roths; be careful since this effective increase in net income might bump someone up into a higher tax bracket.

\* Similarly, employees can now make Roth contributions (i.e., post tax) to SIMPLE and SEP IRAs. Previously only pre-tax was allowed for these. So more types of retirement accounts can be "Rothified," which is good.

\* Small employers will get a new credit of up to \$500 per for making military spouse employees immediately eligible for retirement plans. This credit applies for up to three years for non-highly compensated employees.

\* Roth 401(k)s and Roth 403(b)s will no longer have Required Minimum Distributions (RMDs). (Previously, RMDs were required for such accounts, even though not taxed; on the other hand, for comparison, Roth IRAs have never had RMDs.)

\* IRA catch-up contributions for savers age 50 and over will be indexed to inflation, rather than just being a flat \$1,000 catch-up amount. In 2025, catch-up contributions for employees age 60-63 will be increased to at least \$10,000. Note, for highly compensated employees, catch-up contributions will be required to be Roth contributions beginning in 2024.

\* Employers will be allowed to match student loan payments into 401(k)s, 403(b)s, Simple IRAs, and 457 plans if they choose to do so, which would allow savers to still receive an employer match if they pay off student loans, instead of contributing to their 401(k).

\* You'll be able to take emergency withdrawals of up to \$1,000 per year from your 401(k) and IRA without penalty. Acceptable reasons will be up to the individual.

\* In 2025, automatic (i.e., default) enrollment for new employees will be the norm, and also automatic annual increases to contributions in new 401(k) and 403(b) plans will be added. Employees will be able to opt-out.

## SURVIVOR ASSISTANCE LESSONS LEARNED

This month is aimed at the Beneficiary or the Executor for the Surviving Spouse, and assuming the Surviving Spouse was receiving income from their SBP annuity, and since eligibility for Survivor Benefit Plan Annuity Pay ends with the death of the annuitant, prompt reporting of the death of the annuitant's death can help avoid delay in the final settlement of the annuity. All outstanding checks or Direct Deposits must be returned to DFAS before a settlement of "Arrears of Annuity" may be made. See the last three paragraphs in this article and the Internet link for more AOA info.

Follow these steps:

- STEP 1: Call 800-321-1080 and select the option to report the death of the annuitant.
- STEP 2: Send a copy of the Annuitant's Death Certificate showing the cause of death. Ask the Funeral Director to obtain the Certificate.

Arrears of Annuity (AOA) is any pay due the SBP beneficiary (or annuitant) but unpaid at the time of their death. Because annuitants do not keep a designated beneficiary on file, AOA will be distributed in accordance with the federally-mandated Order of Precedence.

Annuitant pay stops on the last day of the month prior to the annuitant's death. Therefore, DFAS automatically recoups all pay deposited after the date of death from the annuitant's checking account. Any remaining amount owed will be calculated and paid after a complete audit of the account.

Once the annuitant's death has been appropriately reported to DFAS, send DFAS the following to apply for any AOA benefits that may be due to you.

**SF1174** claim form for each beneficiary. <https://www.gsa.gov/forms/trackform/32798>

The person filing the claim can at the same time and in the same envelope for sending in the Death Certificate to the DFAS Military Annuitant Pay office.

## SCHOLARSHIP CORPORATION

We have now passed the halfway mark in our 2023 scholarship application season. The Scholarship Selection Committee is hard at work reviewing applications for completeness in preparation for the awardee selection in June. As a reminder, the MOAACC Scholarship board recently expanded the eligible students and the award is now available for qualified prospective college juniors, seniors, graduate students, and PHD students. With inflation over 8% in the past year, students need more help than ever!

A question we often receive on the Scholarship Corporation is "Who is actually eligible for the Scholarship?" The most frequent type of applicant we see is a child or grandchild of a MOAACC member. However, there are actually three eligible groups of candidates, of which only one requires a MOAACC membership sponsor:

- The descendants and wards of living or deceased MOAACC members;
- The descendants and wards of active duty or retired veterans residing in Brevard County;
- Residents of Brevard County who are the descendants of deceased retired veterans or who are the descendants of uniformed service members who died on active duty

I've highlighted the three groups to show that we do extend the scholarship opportunity to the descendants of the larger veteran community in Brevard County which includes retired enlisted military members as well as non-MOAACC retired officers. (While we hope any MOAACC-eligible officers would consider joining, it is not a requirement.) So we ask that if you come into contact with a worthy student who is the child or grandchild of a retired veteran living in Brevard, please let him or her know about Scholarship Corporation!



## The First Indochina War

The Vietnam War traces its roots to the end of World War II. Indochina, a French colony comprised of Vietnam, Laos, and Cambodia, was occupied by the Japanese Army during World War II. The Vietnamese nationalist movement, the Viet Minh, was formed by Ho Chi Minh in 1941 to resist the Japanese occupiers. Ho Chi Minh, a communist, waged guerilla warfare against the Japanese with support from the United States.

Ho Chi Minh proclaimed the independent Democratic Republic of Vietnam on September 2, 1945, hours after the Japanese signed their unconditional surrender in World War II. He hoped to prevent the French from reclaiming their former colonial possession.

However, in 1946, he reluctantly accepted a French proposal allowing Vietnam to exist as an autonomous state within the French Union. Fighting broke out when the French tried to reestablish colonial rule by shelling the city of Haiphong in December, 1946.

The French forcibly reentered the capital of Hanoi. These actions in 1946 caused the conflict between the French and the Viet Minh, which became known as the First Indochina War, which lasted until 1954. The Vietnamese referred to it as the Anti-French War.

The Viet Minh fought an increasingly effective guerrilla war against France in 1949. They were aided with both military and economic assistance from the newly formed Communist China. The United States, deeply concerned by the spread of Communism, supplied the French military in Vietnam with advisors and funded its efforts against the communist Viet Minh.

The First Indochina War went disappointingly for the French. Rene Mayer, who served briefly as French Prime Minister in 1953, dispatched General Henri Navarre to take command of the French military in Vietnam in May, 1953.


Navarre found a long-term plan did not exist to defeat the Viet Minh when he arrived in Hanoi. The French forces simply reacted to the moves of the Viet Minh. He believed he was tasked to defend neighboring Laos as well.

Navarre sought an effective method for interdicting Viet Minh supply lines through the region. Working with Colonel Louis Bertel, the "hedgehog" concept was developed. This called for French troops to establish fortified camps near Viet Minh supply routes.


