### Roth IRA Conversions, Part III

We finish up on our look at Roth IRA Conversions.

When is one's retirement phase? Do you have sizable tax-deferred assets? Do you have years after you have quit working but before you are taking income (like pensions, Social Security (SS) benefits, and RMDs)? Because of RMDs, the biggest annual bill of many wealthy retirees is not housing costs nor insurance but instead is taxes. RMDs now kick in at age 73 or 75 years old, depending on your birth year. Use this "sweet spot" window of years, where you are likely to have relatively low income, to perform Roth conversions and fill in those low-income years, using up the low tax brackets each year.

Who? If there is a big age gap between a married couple, the older member should normally perform Roth conversions on his IRAs first.

**Widow tax:** The strong probability for a married couple that one spouse dies before the other, and then the surviving spouse now has essentially the same assets and annual income (except for maybe loss of one SS benefit) but now must deal with filing as single, no longer MFJ. More tax burden, with little solutions.

Ok, now that one has decided to go ahead and perform a Roth IRA conversion this year, the next obvious question is how much to convert? This is a complex topic, with many facets. But IMO there is no single absolute correct \$ answer; instead, more likely to be a range of worthy solutions that will be present. And these solutions typically are related to getting near the top of a targeted tax bracket. The 10% & 12% tax brackets are very attractive, and the 24% tax bracket is huge, up to ~\$400k of earned income for MFJ. Next consideration is how to pay the associated additional taxes that will come from executing Roth conversions. This too is complex. The best option is: 1) have a stash of ready cash, non-qualified monies; or next best 2) use tax-deferred monies. For the latter, that means that you will have to withhold monies to pay the tax, to pay the tax. It can be self-perpetuating. But because of the law of 59 1/2, one should only do this option 2) if you are that age or older, else must pay a 10% penalty (in addition to the regular taxes); never a good idea.

Remember to take advantage of Qualified Charitable Distributions (QCDs) if you are charitably minded. This author has written about this option in previous articles. So that is a reason NOT to convert 100% of your tax-deferred assets to tax-free accounts; keep some assets in tax-deferred accounts, to be able to perform QCDs every year if desired.

**Note:** With the recent passing of the One Big Beautiful Bill Act, one aspect has been reduced: The federal tax brackets will remain the same, at least for the immediate future. So that one risk of tax brackets raising has been reduced.

In closing: If you have sizable tax deferred assets, rather than doing a huge Roth conversion of all of it in one tax year, it is likely better to do a series of smaller conversions over multiple years, never exceeding your targeted acceptable tax rate (i.e., tax bracket). Reassess your tax situation at the end of every year.

Roth Conversions are a complex financial topic but are worthy of your financial attention. Judicious use of them can save you tons of tax dollars sent needlessly to the IRS and instead keep them in your pockets.

## LEGISLATIVE AFFAIRS

### Inching Forward

There are nine remaining annual government funding bills to be passed before the expiration of the current Continuing Resolution (CR) on 30 January 2026. The Christmas recess seemed to sneak up on the Congress since the longest government shutdown ended on 12 November 2025 with several ill-fated attempts in the Senate to extend Obamacare subsidies which expire on 31 December 2025. As part of the CR extension deal, FY2026 funding was authorized for Military Construction and Veterans Affairs; the Food and Drug Administration, Agriculture and Rural Development; and the Legislative Branch.

Small steps of progress were made before the Christmas recess on five of the remaining nine bills needed to fund the rest of the government through the end of FY2026, specifically a five-bill “minibus” to fund Transportation and Housing and Urban Development; Defense; Labor, and Health and Human Services; Commerce and Justice; Science and Interior. However, it has stalled, purportedly due to it having some \$5 billion in earmarks, a construct that was banned more than a decade ago (in 2011) only to be resuscitated under a new moniker, Congressionally Directed Spending (CDS), with its own set of “rules of the road”. It was, and remains, the “grease” that oils the wheels of governance through compromise. On a positive note, the 2026 National Defense Authorization Act, authorizing \$900.6 billion for defense programs, moved through a series of hurdles after the House passed its version by a vote of 312-112, a sure sign of bipartisan support.

Meanwhile, the Republican controlled Senate is under pressure to eliminate the tried-and-true filibuster, a potent legislative tool that gives the minority party in the Senate some leverage, if not outright veto power. As described in an op-ed by the Treasury Secretary, Scott Bessent notes that Senate Democrats most recently used it to hold the country hostage during the latest government shutdown which inflicted “tremendous harm on the nation”, including: \$11 billion in permanent economic damage; an estimated 1.5 percentage points in lost GDP growth in the fourth quarter of fiscal 2025; 9,500 canceled flights; and the delayed paychecks to 1.4 million federal workers. He dubs it “a historical accident that has evolved into a standing veto for the minority and a license for paralysis” and calls for Republicans to acknowledge that the filibuster no longer serves the country — and should end it for the following reasons.

The filibuster is not in the Constitution. And, while its defenders argue that it ensures compromise, encourages bipartisanship, and protects minority rights, in today’s charged political environment, the minority party has abused it to the

point of rendering the Senate “almost useless as a deliberative body”. And the filibuster has not been sacrosanct in the recent past, given the tit-for-tat efforts to eliminate it in 2013 for presidential nominations other than Supreme Court justices by Democrats, and in 2017 for Supreme Court nominations by Republicans. Bessent observes that “each side justified its move as a response to unprecedented obstruction by the other and that each time, the Senate survived”. Hence, while some senators are reluctant to go further for fear the opposition will one day use the same power against them, they ignore the fact that that power will be leveraged against them whether they end the filibuster or not. The bottom line is that the filibuster prevents the Senate from functioning as intended, given the sad fact that major legislation is now passed only through reconciliation, executive fiat, or brinksmanship, while the 60-vote threshold has become a convenient excuse for inaction. Bessent argues that the test will come soon enough by 30 January 2026 when the current CR expires. “If Democrats refuse to negotiate in good faith and close the government on 30 January, then Republicans must instantly abolish the filibuster.” My sense is “be careful what you wish for” because the script could be flipped sooner rather than later given the upcoming November 2026 elections.

I'll admit we didn't always feel that way. It seemed, for instance, the squirrels came and stole the food we put out for the birds. We concluded, with our prejudiced mindset, they were plain, ordinary thieves, and we wanted to scare them away. The birds didn't mind though. They shared, willingly, with squirrels, rabbits, and more, even eating out of the same feeders and dishes at the same time. Finally, the squirrels' lively antics won us over.

We've now come to enjoy the whole diversity of plants and animals. We try to treat them equally and truly enjoy including them in our lives.

I think diversity, equity, and inclusion work well with people too. When we serve with an openness to care for all people willingly, appreciative of God's variety of gifts, then, I believe, the benefits accrue to us all.

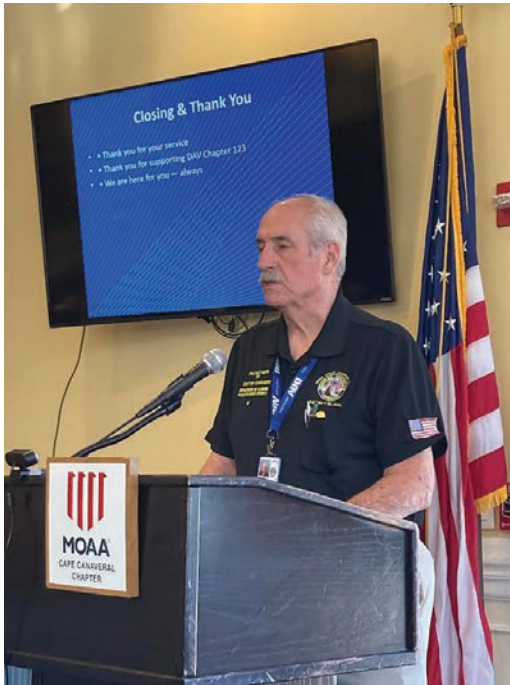

# IN MEMORIAM

## *Canaveral Port Authority Chair, Retired Coast Guard Admiral Wayne Justice Passed Away Nov. 8*

**SERVED 11 YEARS AS A PORT CANAVERAL COMMISSIONER, INCLUDING THREE TIMES AS CHAIRMAN**



Rear Admiral Wayne Edward Justice, U.S. Coast Guard (Ret.), 70, of Cocoa Beach, Florida, died peacefully on Saturday, November 8, 2025, at Health First's Holmes Regional Medical Center in Melbourne, Florida. He served in the U.S. Coast Guard for 37 years and 11 years as a Port Canaveral commissioner, including three times as Chairman.

Admiral Justice was born in Seattle, Washington, raised in Staten Island, New York, but called Brevard County, Florida, his home. He was a proud graduate of the U.S. Coast Guard Academy, Class of 1977, and played football on the Coast Guard Bears team. Wayne was passionately proud of commitments to service, especially military members, first responders, and his beloved Coast Guard, and had an enduring enthusiasm to energize young people to carry the torch of service for their community and country.

Wayne's dedication to inspiring the next generation of leaders was recognized by U.S. Senator Rick Scott, who appointed Wayne to serve on his selection committee for students seeking a Congressional appointment to our nation's military academies. While serving in the Coast Guard, Wayne most enjoyed his time at the White House and in Key West. Among the many roles and responsibilities he had throughout his military career, he loved commanding cutters. He also cherished carrying the "football" that contained the nuclear codes for Presidents H.W. Bush and Bill Clinton.

Wayne was proud of his 2014 election to the Canaveral Port Authority, where he served for 11 consecutive years, including three times as Chairman. He made many contributions to the Space Coast community, including promoting the space industry, the safety and benefits of LNG (Liquefied Natural Gas) as a marine fuel, the Brevard Zoo, and the importance of port security. He was also a tireless supporter of the Brevard Veterans Memorial Center, an active member of the Military Officers Association of America (MOAA) and MOAA Cape Canaveral, and its Good Deeds Foundation.

Wayne was also a "baller." Not only did he enjoy watching and supporting his New York Giants and New York Yankees, but you could find him on most Mondays and Thursdays playing basketball in the Old Farts Basketball League in Cocoa Beach, FL.

Wayne loved everything on the water, including boating, lobstering in the Florida Keys, a red sunset, and charbroiled oysters. Blessed with the gift of conversation, he could easily engage with anyone, telling stories of his endless adventures.

Wayne is survived by his wife, Barbara; daughter, Justice Behrmann (Katie Behrmann); son, Michael Justice (Alexa Staubus). A private memorial service will be held on December 16, followed by a full military honors burial at Cape Canaveral National Cemetery in Mims, Florida.

It was sadly also marked by the unexpected loss of one of the most impactful MOAACC and Space Coast Community members, RADM Wayne Justice, USCG, Ret. The GDF year end wrap up includes many great highlights, the details of which you will read about in this and subsequent Intercom issues:

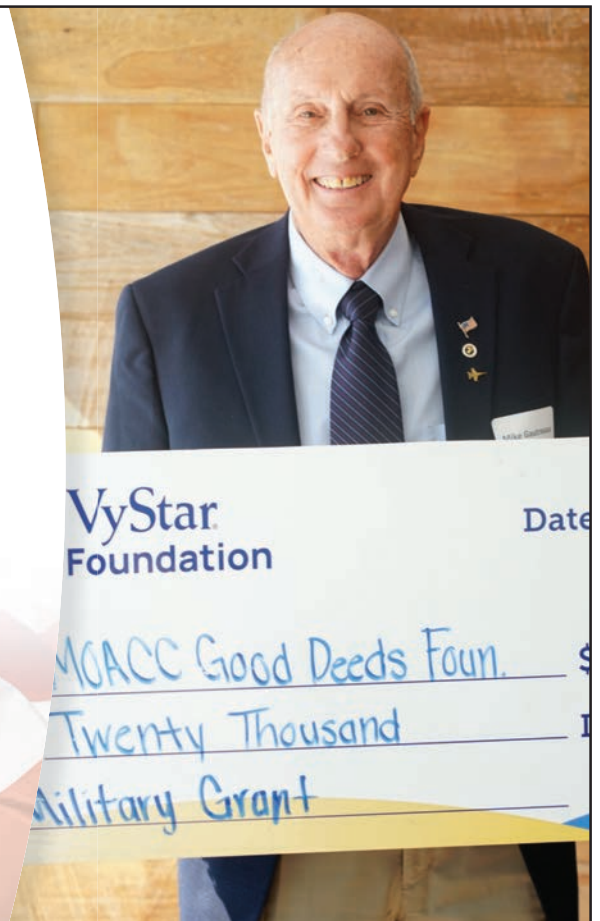

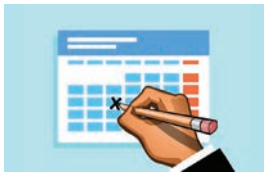

presented with a flag and helped raise it there. In addition to the schools, all 14 JROTC programs in the county received its own flag.

As of mid-December, all public and private high schools in Brevard County were provided America 250 Flags, with many already flying. As far as we know, Brevard is the first county in Florida, and perhaps the continental US, to have done such a project.

## Is Your Email Address Still “@cfl.rr.com”? Here’s What You Need to Know

Many of our members have used Roadrunner-style email addresses (such as cfl.rr.com, @rr.com, or roadrunner.com) for years. These accounts were originally created through Bright House and Time Warner Cable and are now part of Spectrum. While these email addresses still work today, they are considered legacy accounts, and several changes in recent months have affected their reliability.

### What’s Happening?

- Spectrum no longer creates new Roadrunner-style email addresses. Some users have reported trouble connecting these older accounts to email apps like Outlook, Apple Mail, or smartphones. Spectrum support has indicated that parts of the old Roadrunner system are being phased out or migrated to newer platforms. In some cases, if a customer stops Spectrum internet service, the old “rr.com” mailbox may be shut down.

### Why This Matters

For many long-time users, the cfl.rr.com address has been stable for decades. But as the legacy system ages, the risk of service interruptions grows. Losing access to an email account can also mean losing password recovery options, contacts, subscriptions, and important messages. Additionally, within MOAACC we are now seeing a noticeable increase in “bounce-backs” when sending out chapter communications. Emails sent to cfl.rr.com addresses—including the Intercom, Five Things, event notices, and other important updates—are bouncing at a higher rate than in the past. When an email “bounces,” it means the message did not reach the member. As a result, some members may not be receiving critical chapter information without realizing it.

### Recommendations

If your cfl.rr.com email is still working, you do not need to give it up immediately. However, now is an excellent time to begin preparing for the future:

1. Set up a new, modern email account. Consider creating a free and reliable account such as Gmail (Google), Outlook.com (Microsoft), or Yahoo Mail. These are well-supported and are not tied to your internet provider.
2. Update your important accounts gradually. Begin updating your email address with banks, medical portals, Social Security, recurring bills, and newsletters. Take your time—this transition does not need to happen all at once.
3. Save or forward your important messages. Make sure any vital information stored in your old Roadrunner mailbox is backed up or forwarded to your new address.
4. Keep your Roadrunner address active if it works. Continue checking it for any notices from Spectrum and for messages from contacts who have not yet updated their records.

### Bottom Line

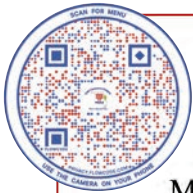
Your cfl.rr.com address may continue to function for now, but it is part of an older system that could eventually be discontinued. Taking a proactive approach—while the account is still working—will help ensure you don’t lose important messages or miss essential chapter communications.
