

What Are the Essential Documents for an Estate Plan?

A well-crafted estate plan typically includes six or seven key documents. Many people are surprised to learn that planning for medical situations is just as important as addressing financial matters. If your plan is missing any of these core elements, your loved ones may face unnecessary legal delays, added expenses, or even be unable to help you in an emergency. Having these documents up-to-date offers peace of mind—knowing you've taken thoughtful steps to prepare for the unknown.

1. A Will Is Essential

Whether or not you create a trust (discussed below), you should always have a valid, current Last Will and Testament. Your will directs how assets without a named beneficiary (such as personal property or accounts held solely in your name) will be distributed through probate. It also allows you to name guardians for minor children and appoint a personal representative (executor) to manage your estate.

2. Durable Power of Attorney

If an accident or illness leaves you incapacitated, who would manage your finances, legal affairs, and day-to-day obligations? Many assume that family members automatically have this authority—but that's not true. To ensure someone you trust can act on your behalf, you must create a Durable Power of Attorney (POA). This legal document empowers your designated agent to handle banking, real estate, insurance, taxes, and other financial matters if you're unable to do so.

3. Health Care Directives

Your estate plan should also include documents that address your medical needs. A Health Care Surrogate appoints someone you trust to make medical decisions if you're unable to do so. A Living Will expresses your wishes for end-of-life care, such as whether you want life-sustaining treatments. A Health Care Workbook provides detailed preferences and values regarding your medical care to guide your surrogate's decisions.

4. Pre-Need Guardian Designation

If your POA or health care surrogate is challenged or deemed invalid by a court, a Pre-Need Guardian designation allows you to pre-select someone to assume responsibility for your personal and/or financial affairs. Without this, a court-appointed guardian may be chosen—potentially not someone you would prefer.

5. Trusts: A Foundation for Asset Protection and Planning

A trust can serve as the cornerstone of your estate plan, depending on your goals. Trusts can help:

- Avoid probate (Revocable Living Trust)
- Provide for a disabled loved one (Special Needs Trust)
- Protect assets and qualify for Medicaid (Irrevocable Asset Protection Trust)
- Support a charitable cause while reducing taxes (Charitable Remainder Trust)

A trust allows you to manage and distribute assets according to your wishes, both during your lifetime and after. You may serve as the initial trustee and beneficiary, with successor trustees and beneficiaries stepping in upon incapacity or after your death.

6. Regular Reviews and Updates

Life events—such as marriage, divorce, the birth of a child, relocation, or changes in the law—can affect your estate plan. Review your documents at least every 2 years, or anytime your personal circumstances change, to ensure your plan reflects your current wishes and legal requirements.

A Reset on the Budget

The One Big Beautiful Bill (OBBA), which MOAA has dubbed the "megabill," was signed into law on July 4, 2025, by President Trump. According to the Congressional Budget Office (CBO) it could add up to \$3.3 Trillion to the national debt over the next ten years. The new Public Law No. 119-21, passed by slim Republican majorities in both chambers, assumes the best-case scenario, which projects vastly improved economic conditions with an artificial intelligence-driven efficiency boom that raises incomes and tax receipts while keeping federal spending under wraps.

It is important to understand what this Reconciliation Bill does to reset and make changes to existing laws related to spending, revenue, and the debt limit by making changes to mandatory spending programs (e.g., Social Security, Medicare, Medicaid), setting tax rates and provisions, and setting broad targets for discretionary spending. It is a fast-track process designed to avoid the Senate filibuster when one party has control of both chambers of Congress. Nonetheless, the annual appropriations process must also proceed to allocate specific funding levels to the various government agencies and programs, aimed at discretionary spending (e.g., Defense, Veterans Affairs), within the broad target levels set by the Reconciliation Act.

As unappealing as many pundits and Democrats characterize this new law, it also sets conditions for future negotiations in Congress. For example, by making President Trump's first-term tax cuts permanent, it may force Democrats to join with Republicans to finally address our deteriorating fiscal situation in a manner more in line with Republican policy priorities. As in past attempts for our elected representatives to address the situation responsibly, this new law sets a new baseline for future negotiations.

Meanwhile, the Federal Reserve (FED) finds itself in a precarious position in which the nation accumulates more debt, tariffs increase inflationary pressure, and the Treasury market flutters in the hope that another disastrous blow to the economy (i.e., COVID-19 Crisis) does not occur. As an independent player in this ebb and flow of Congressional and Presidential action, the FED's mission is to foster a healthy and stable economy and financial system for the USA by promoting maximum employment, stable prices, and moderate long-term interest rates. Its mandate is to conduct monetary policy to influence interest rates and credit conditions, to supervise and regulate financial institutions to ensure their safety and soundness, and to minimize risks to the overall financial system. Additionally, it provides financial services to banks, the US Government, and other institutions, including operating the payments system.

As a taxpayer, there is certainly some good news in the new law including a new \$6,000 deduction (\$12,000 for couples) for those 65 and older who earn up to \$75,000 per year (or \$150,000 for couples); this deduction decreases for higher earners and phases out for singles who exceed \$175,000 per year and couples after

\$250,000 per year. The standard deduction increases to \$15,750 for singles and \$31,500 for couples. For homeowners, the State and Local Tax provision (SALT) raises the cap on deductions for these items from \$10,000 to \$40,000 for households with incomes below \$500,000. The bill also repeals Biden-era student loan forgiveness programs with other sensible measures that reward borrowers for making on-time payments, for example. the new law includes \$150 billion in DoD funding, some of which addresses MOAA focus areas:

- Better BAH: \$2.9 billion in supplemental funds for the Basic Allowance for Housing (BAH), though details on how the funds will be spent remain unclear. MOAA has fought to restore BAH to 100% of projected housing costs.
- Unaccompanied Housing: \$1 billion for Army, Navy, Air Force, and Space Force housing, and more than \$230 million to support the Marine Corps Barracks 2030 program.
- Health Care: \$2 billion in additional funding for the Defense Health Program.
- Child Care: \$100 million in childcare fee assistance, and another \$62 million to modernize staffing at DoD childcare centers
- More Spouse and Family Support: \$100 million for Impact Aid payments (designed to assist school districts with large DoD populations), and \$10 million for military spouse professional licensure.

POINTS TO PONDER





Countdown to the 250th: BCSO Independence Day Parade of 2025 is a Patriotic Launch





Finishing just before the rains came on a cooler than usual Fourth of July, the Sixth Annual Brevard County Sheriff Office (BCSO) Independence Day Parade was a good start of a special year long countdown to mark America's 250th Birthday. There were more first responder entries than ever as Sheriff Wayne Ivey and his team also made sure security was everywhere — just in case, given threats nationwide the days before.

There were hundreds and hundreds of spectators lining the route from Merritt Island High School south on Courtney Blvd to Merritt Ave. While other parades may have had more spectators in the five previous years, all were enthusiastic and applauded the entrants, including four major veteran groups — Veterans Memorial Center, MOAA Cape Canaveral Chapter, Marine Corps League and Sons and Daughters of the American Revolution.

There were three big stars of the parade this year: Sheriff Ivey who greeted everyone at the finish line, Grand Marshal Medal of Honor Recipient SFC Melvin Morris, USA Ret, and 99 year old WWII and Korean War Veteran Maj George Rosenfield, USA, Ret.

The BCSO Huey Helicopter flew overhead much of the Parade as hand held flags and pounds of candy were passed out to spectators along the route. So many of those who came to watch were children - a good omen for the future of American patriotism.

The photos below were taken during final set up for the parade of some of the over 70 participant groups. They capture the enthusiasm and outright fun of keeping this old American tradition alive and well. It is worth remembering that this parade was even held in 2020 during the Covid restrictions, though that year it was a Parade in Reverse. Participants lined route 520 on Merritt Island as hundreds of cars passed by heading to the beach with many honking while their passengers smiled and waved.



A New Partnership:

Important Reminder for Retirees, Spouses and Dependents regarding Military ID cards

Military retirees are encouraged to update their Uniformed Services Identification (USID) cards to the **Next Generation USID card**.

The Department of Defense has transitioned from its legacy paper-based Uniformed Services Identification (USID) card to a more secure, next generation USID card. The Next Generation USID card incorporates an updated design and security features to deter counterfeiting and fraud, and is printed on a plastic cardstock. USID cards are issued to retired and reserve members, dependent family members of uniformed Service members, and other eligible individuals in accordance with DoD policy to facilitate access to benefits, privileges, and DoD bases. The Next Generation USID card does not change the populations who are eligible to receive the current card.

<u>Legacy USID cards remain valid through their expiration date</u>, however, individuals with an indefinite (INDEF) expiration date on their legacy USID card may replace those ID cards with a Next Generation USID card.

USID cards may also now be renewed online. Please see the online USID card renewal page for more information.

There are several ways to make an appointment to get a new ID card. (1) You can visit the RAPIDS ID Card Office Locator website to find the closest office and either call them to make an appointment or (2) schedule your own appointment using the website https://idco.dmdc.osd.mil/idco/ To make an appointment using this site select the "ID Card Office Locator & Appointments" block. - do it now!

Rescued Meets His Rescuer

A pilot rescued by helicopter in Vietman last year met his rescuer at Myrtle Beach AFB recently while investigating still another rescue.

The reunion took place when Lt. Col. James E. Ketchum, chief of safety for the 363rd Tactical Reconnaissance Wing at Shaw AFB was assigned to investigate the recent ditching of a jet off Myrtle Beach.

During the investigation Col. Ketchum questioned helicopter rescue pilot Capt. Fernand Espiau who had plucked the pilot that rescued me in Vietnam!"

The resulting conversation brought out that Col. Ketchum had had to eject from his jet in July, 1967, while returning from his 75th mission over North Vietnam. Capt. Eapiau rescued him.

Captain Espiau's crew at Myrtle Beach include Staff Sgt. Robert O. Smith who was with Espiau Vietnam the day he rescued Col. Ketchum.

Sergeant Smith recalled, "Both missions went off real smooth"

On July 7, 2025, the 30th annual Parachute Party was held at IRCC to honor Jim Ketchum and mark the 77th anniversary of his remarkable

mission over North Vietnam. During that mission, Jim's aircraft was disabled, forcing him to eject over South Vietnam. He landed near a South Vietnamese firing range, where he was greeted by a South Vietnamese sergeant who identified himself as a fellow paratrooper. Jim, making his first parachute jump, replied that he was an American paratrooper. The sergeant, noting Jim's less-than-graceful landing, joked, "You #10," referring to the toughest type of jump landing—a reference to Jim's rough arrival and a bloody forehead. At that time, Air Force personnel did not routinely practice jumping from single-engine aircraft except via ejection simulators.

Shortly after landing, a helicopter transported Jim back to Tan Son Nhut Air Base in Saigon. The previous day, July 6, Jim was awarded the ABLE AERONAUT Award for successfully bringing home a plane with only one functioning engine. The RF-101, a heavy reconnaissance aircraft equipped with cameras, bears the motto "Alone, Unarmed, Unafraid." Jim served with the "Polka Dots" unit during this period.

Jim left Vietnam in September 1967, having completed 167 missions in Vietnam including 100 over North Vietnam. Following his service overseas, he dedicated 12 years to teaching at the Training Command. Of those, 8 years were spent at the Instrument Pilots Instructor School, and then 4 years at Williams Air Force Base from 1962 to 1966 as a student squadron instructor.


