On November 15, 2022, MOAACC held its Business Meeting and election of 2023 chapter leadership. As not every member attended, I'll recap it here. The full presentation is online at 2022 Business Meeting

We are the largest, and without a doubt, best, most active Chapter in MOAA! We make a difference — Nationally, locally, and for our members.

MOAACC continues to receive MOAA awards of excellence, e.g., COL Martin J. Harris Communications Award and Five-Star Level of Excellence Chapter Award for 2021. Accomplishments include MOAA's Foundation Community Grant to assist area Vets-in-Need and hosting MOAA's CAPT Erin Stone JAGC, USN (Ret), Senior Director, Council and Chapter Affairs for a National Chapter Visit that went extremely well.

Our Legislative Affairs Committee monitors both MOAA National advocacy efforts and State/Local actions and then coordinates Chapter advocacy via Intercom, Five Things, and Website.

Members are encouraged to sign up on MOAA's New Legislative Action Center and take action when asked. MOAA is increasing emphasis in this area for LOE scoring.

Your Chapter is fiscally sound. However, we are experiencing a decline in membership with rising expenses which may require an increase in dues in the future. This can be avoided by adding new members and more advertisers. Every member needs to focus on recruiting at least one new member. Membership retention is an area we are focused on as well as increasing member participation.

MOAACC Scholarship Corporation is fiscally stable and has expanded eligibility to include PhD students. Our Good Deeds Foundation provided grants of \$82,075 during their FY2022 ending in September and \$21,500 to date for FY2023. Funds supported about 1,000 people to include JROTC, storm relief, active-duty families, NVHS, and Honor Flight. Their charity Golf Tournament is December 10th.

Our Volunteers are our strength, and we need more members to become actively involved! Many committees are one person deep, and they can use your help.

While our Chapter is Good, with some effort we can be better and make an even bigger impact! Members: recruit a member, volunteer get involved, and take action on legislative issues.

The 2023 leadership slate was elected and will be installed during January 17, 2023 luncheon.

LEGISLATIVE AFFAIRS

Unfinished Business

The pundits are certainly having a heyday as they analyze and attempt to explain the recently concluded (almost) 2022 midterm elections, but the ultimate and obvious conclusion is we are heading into the next two-year period with split control of the Congress with the Democrats retaining control of the Senate and the Republicans taking the House.

This will have serious consequences in several aspects of national legislative affairs:

- First, any thought of achieving an ambitious Biden agenda is gone, limited mostly to judicial appointments given the Senate role to advise and consent on them by a simple majority vote.
- Second, Given the "scant Republican majority" and the multiple side deals (read power sharing); electing Rep. Kevin McCarthy (R-CA) as the next Speaker of the House is a challenge.
- Third, whatever might be achieved over the course of next two years will be greatly limited and an outcome of compromises made across party lines and concurrence with the closely split Senate—in short, bi-partisanship! This is not a bad word in my lexicon and we can only hope they find a way.

What the House Republican priorities will be is an open question but judging from various Members' statements, these will likely include investigations (largely a big waste of time), and getting spending under control. There are also expiring tax cuts and a Democratic push to revive payments to low-income families with children. Some Members have expressed a desire to compromise in response to what they perceive to be the will of the voters for Congress to "work together in some areas but not continue on the path we were on". We shall wait and see.

Before we even get into the new Congress in early January 2023, the current "lame duck" Congress has lot of unfinished business to tackle with high stakes for the finicky economy. First, there is a December 16th deadline on the Continuing Resolution Authority (CRA) which funds the government. This could be resolved with another short-term CRA which pushes the ultimate solution to the new Congress or a spending OMNIBUS bill that covers government operations through the end of the fiscal year, 30 Sep 2023. That would be optimal and was used in the last fiscal year. Without either one of these approaches, the government will shut down once again, something that should be avoided at all costs.

Next is the ever-present and growing national debt whose ceiling must be extended once again or suspended (highly unlikely since it leaves the Republicans with no leverage) or the government defaults. Although the debt ceiling milestone does not occur until later in 2023, from economic perspective, earlier resolution of this is better than later. Alternatively, the Democrats may attempt to resolve the issue using the sledgehammer approach known as reconciliation but it is not clear if sufficient time remains for the current Congress to apply it. This means a longer-

FINANCIAL LITERACY

John C. Murphy, COL (Ret) THE AIRPLANE WILL

This is not an article on estate planning for pilots. The "Airplane Will" refers to the last-minute "stop-gap" estate plan update for clients who are about to take a trip. Most attorneys who do estate planning are familiar with this syndrome, where a client has procrastinated for years in updating their estate plan, and suddenly is motivated by an impending trip (or other crisis) to get it updated. The client often calls only days before the travel, and needs it to be done overnight.

The implications are enormous, and bear some thought ...

- a. A last-minute estate plan is rushed and all options are not explained and discussed.
- b. It is considered as a "stop-gap" plan, with the client's promise that after the crisis (travel or whatever) they will come back to do the job right, and the clients are lulled into a false sense of security.
- c. Inreality, the client's sense of crisis is relieved, and they seldom come back to do the complete job. Many critical decisions are ignored in the interest of haste:
- d. The overall plan may be overly simplified, ignoring the benefits of a trust/will, health care directives, Powers of Attorney, Living Wills and Pre Need Guardians because the client won't have time to review them.

- e. Short-changing the consideration of fiduciaries, such as trustee, personal representative and attorney in fact and their backups. In such situations, no time is spent thoughtfully vetting the possibilities and doing the necessary research to select the best options.
- f. For your selected fiduciaries, likely you will need to educate them as to your accounts and bills with a secure way to share your user IDs and passwords.
- g. If you are doing last minute estate planning most likely you also need to update all your beneficiary designations to life insurance and retirement accounts.

This article is encouragement to do your estate planning now before some unexpected event occurs. Take the time to get your estate plan in order before your next trip. Have a Happy New Year!





SURVIVOR ASSISTANCE LESSONS LEARNED

The MOAACCC Survivor Assistance Team has had the great privilege of helping a lot of Surviving Spouses get through some very difficult times. I wondered what the single greatest cause of difficulties Surviving Spouses had to deal with. It was getting the death certificates to accurately document the cause of death and any contributing causes. It would seem like it would be very straightforward for the physician that signed the death certificate to be aware of the actual cause of death AND any contributing causes, but unfortunately, far too often that is not the case.

If that doctor was not the primary care doctor for the deceased, the only contact with the deceased may have been when the person showed up in the ER, or the Hospice facility. They end up knowing what the actual cause of death was, but have no real history on the deceased to know that there may have been illnesses that were contributing causes.

So, the doctor does not know to put that information in the "Contributing Causes" section of the long form death certificate. They need to know that VA needs this information to connect any VA Presumptive illnesses to things like exposure to Agent Orange to approve benefits claims for the Survivor. The fix for that is **the Funeral Director makes certain that the person signing the certificate is aware of the need to fill that information in**, and has documentation given to him/her from the doctors treating the deceased proving the deceased was being treated. The best way to do that is to get signed and notarized copies of medical records beforehand to provide to the Funeral Director to then provide to the signing doctor.

This needs to be done BEFORE the paperwork is submitted to the state of Florida to get copies of the death certificates. The stress and anxiety are already high during that time, and the hassle of the process to amend the original death certificate can be very debilitating for the Survivor. Spare them that, by simply making sure the people signing the certificate have all the info they need beforehand!

Some more good news came just before Thanksgiving when the County Commission approved the design of a magnificent Amphitheater to be built in VMC's Veterans Memorial Park in the Fall of 2023. The supporting infrastructure including power, irrigation, lighting, more restrooms, a food service facility and exercise stations along the 5k VMP pathway, should begin in early 2023.



For the month of October, the Veterans Memorial Center (VMC) worked with Brevard JROTC Units, the Good Deeds Foundation, and other organizations to provide relief supplies to hurricane victims in SW Florida and flooding victims from Ian in Northern Brevard. Within hours of beginning to search for a driver to take, what became thousands of pounds of relief supplies in two separate 20ft rental truck runs, the VMC County Parks and Rec main contact raised his hand.

Fred Ameigh is the Parks and Rec Central coordinator and covers many parks including the VMC and Veterans Memorial Park. He wanted to use his off hours to support the project and we needed someone reliable to deliver the supplies into the unknown. 



Military Payment Certificate (MPC)

Recently I was poking in the far reaches of my desk and turned up a ten cent MPC. My first thoughts were that it must have been a helluva a liberty to return with a dime in my pocket! Upon recall it is a practically worthless souvenir from an early 1960's port call in Naha, Okinawa.


What were MPC's? MPC was used by the Department of War and subsequently, the Department of Defense to pay personnel in foreign countries. MPC was similar to the Allied Payment Certificate (APC) which was used by the Allies when they occupied foreign countries. While MPC's were in dollar denominations, APC's were in francs, lira, etc. MPC was issued with the purpose of maintaining trade in local currency and only used on the bases. MPC was exchanged for local currency on the base. Theoretically this kept US dollars off the black market and helped stabilize the local currency As could be expected, a black market developed off base to convert MPC to local currency. To counter the black marketing, at unannounced times the base would lock down and convert to a new series of MPC. This Conversion Day was called "C Day". A total of 13 series of MPC's were issued between 1946 and shortly after the end of hostilities in Viet Nam in 1973. The last area to use MPC's was South Korea.



As MPC's were issued by the DoD and not Treasury, they had no

value except on the base. MPCs could be converted to US dollars when the service man was leaving the MPC zone.

Once the MPC saw its last use in South Korea, the concept lay dormant until the Eagle Card, a stored cash value card, used in Bosnia, Kosovo, Djibouti, Iraq and Afghanistan. I'm glad that I had the experience of using MPC as it wouldn't be the same finding a piece of plastic in the far reaches of my desk.

Brevard County has dozens of veteran organizations that assist veterans and their families in times of need. The China Marines in the Pacific

The first mission for the 4th Marines after its rebirth was the seizure of Emirau Island in the St. Mathias Group. The objective of this operation was the construction of airfields to enable American planes to bomb the huge Japanese base at Rabaul.

The next assignment was to join the 22d Marines in the 1st Provisional Marine Brigade for the recapture of Guam which had been seized by the Japanese on 10 December 1941. Guam would provide the United States with air bases to attack Japan while also affording a good anchorage for the Navy.

The 4th Marines, except the 3d Battalion in reserve, were in the first assault waves to hit the beaches on 21 July 1944. As the Marines moved inland they encountered stiff resistance, resulting in the ordering ashore of the 3d Battalion. Regimental units reached the slopes of Mount Alifan by late afternoon. After turning back the Japanese counterattack, the 4th Marines were ordered to continue their drive on Mount Alifan. The two battalions in their move up the slopes found the enemy waiting, entrenched in caves and tunnels. The rough terrain led to the summit which was especially rugged. The Marines found it to be indefensible as the Japanese had made the same analysis because no enemy forces were found. Regimental personnel concluded their assault at nightfall, having already attained the crest of the mountain. They then dug in to await further orders which would be an assault on the neck of the Orote Peninsula.

The Leathernecks found Japanese resistance to be extremely stubborn. The Japanese had failed to take advantage of the precarious situation. They didn't counterattack on the night of the 24th but waited until the following evening to strike at the Marines. The regiment, however, was far better prepared to meet a counteroffensive. The enemy attack proved to be a wild, headlong, banzai charge. The onslaught was nonetheless beaten back by the Marines with the Japanese sustaining severe losses. A platoon from Company A, 1/4, which had been brought up to assist the 22d Marines, was the only unit from the 4th Marines to engage the enemy in this encounter. The platoon killed an estimated 250 during the battle. The 4th Marines led off the offensive on the Orote Peninsula. They fought

their way through pockets of enemy defenders for the next three days. The peninsula's final capture was on 29 July.

The regiment remained on Guam for three weeks following the end of organized resistance, participating primarily in mopping-up operations. By 30 August, all units of the regiment had embarked on the return trip to Guadalcanal. (Next month: The China Marines on Okinawa)

The Last Resort: Good Deeds Foundation Helps a Special Veteran and Family

After working for many days with many agencies, the VA Veteran Support Office at the Melbourne Vet Center had one more organization to contact that might help in a dire situation. A US Army Veteran of 11 years, with combat related VA issues, had a tough decision. His wife had just landed a well-paying job in North Carolina that would allow them to start fresh after the landlord in Brevard raised the rent with numerous household repairs not being done. He spent many years on and near Ft Bragg and was very comfortable with the change and landing his own job and volunteer roles.

The problem was her new company would not cover the relocation costs and all available funds had been used up to prepare to move by 31 October. There was no money for a special rental truck they would need to move the entire family of five including their special needs daughter.

The veteran located the truck at a reasonable cost after several quotes, but could not cover the \$570 needed to procure it within a couple days to make sure they could move. Getting the check within 24 hours of the Melbourne Vet Center call to Good

Deeds Foundation was to him a miracle and a blessing. Below he accepts the funds from GDF President Donn Weaver at the Veterans Memorial Center Museum, next to a mannequin wearing the uniform the veteran wore not long ago in combat in SW Asia.

There is more to this story. The special needs daughter is adopted by the family. She was five years old when she lost her own single Dad father to a tragedy. Her father was a platoon member for several years working under our veteran. The veteran would not let the daughter be passed into foster care, but would honor his junior enlisted warrior and raise her together with his wife and two other children.

Their oldest son just completed US Army boot camp at Ft. Jackson, SC, as a junior in high school heading into his senior year. The veteran and his wife had to miss that graduation ceremony due to funding issues, but will make sure they are available next summer when their oldest completes Advanced Individual Training.

In talking about patriotism, honor and commitment, this family sets a high bar. We wish them every success as they restart their lives with high hopes.

LEGISLATIVE AFFAIRS cont'd

term bi-partisan deal to raise the borrowing cap is more likely in the new Congress. Non-Discretionary spending questions are embedded here, in particular bulking up the finances of Social Security and Medicare, two of the largest expenditures along with servicing the interest on the national debt. In any case, the high rate of inflation and rising interest rates are exacerbating these problems.

Further complicating the FY2023 budget funding crisis is the Biden Administration's recent request for \$47.7 Billion in new emergency spending authority. This includes \$37.7 B to support Ukraine with additional equipment and to replenish DoD stocks; it would carry the Ukrainians through the end of the fiscal year. It also includes \$9.25 B for continuing access to COVID vaccines and treatments, and to support long-COVID research, and an estimated (but not final) amount for responding to recent natural disasters in Florida and Puerto Rico among other places. Each of these seem to be legitimate needs that should be funded without delay either now or immediately in the new congress.
