


The Republicans Take Charge

With incoming President Trump's inauguration a few days away, media anticipation about what his first moves will be and what sorts of policy changes he will implement are approaching hysteria levels. It seems almost counterproductive trying to predict what will happen rather than taking a more prudent "wait and see" stance and give the new leadership an opportunity to craft meaningful policy and legislation, the real "meat and potatoes" of governing. This is not to suggest that insightful analysis, with some predictive consequences of this or that policy, is not helpful as the process plays out. In the Congress, which is the focus of this space, there are many more actors in the mix and, because much of what is to come must be undergirded by legislation and appropriations, a modicum of anticipation and predictive analysis is warranted, especially in the national defense sphere.

Hearings are underway in the Senate for key cabinet and other senior government positions. A big push is also underway to secure sufficient Republican votes for some of the more contentious nominees including Pete Hegseth to be SECDEF among others. Deference to the new President is certainly apropos but so is close scrutiny of the nominees' respective qualifications and prospective positions on important policy matters. Based on the Senate Armed Services Committee hearing that occurred earlier this week, hardly any Republican or Democrat Senator focused on some of the "life or death" issues facing the Pentagon. These include the growing threat of China's burgeoning military capability, the dilapidated state of the US industrial base to produce weapons and ammunition needed to fight the next war for more than a few days or weeks, or how drones and artificial intelligence will impact near-term and future warfare. Similar challenges exist in the US Intelligence Community (IC) where similar hard-nose scrutiny is needed in subsequent hearings. The US Senate needs to take its "advise and consent" role seriously.

Since my last update, Speaker Johnson was re-elected albeit with some last-minute drama to garner sufficient votes oriented around spending and our growing deficits and the national debt. As usual, the best the House could do (with a complicit Senate) was kick the can down the road on a FY2025 budget only to face the prospect of another government shutdown in March. Republican spending plan continues to elude the Republican-controlled House where the entire conference must unify to overcome their tenuously slim majority. Given their regional and ideological differences, it is difficult to imagine this necessary unity while the prospects of the House democrats bailing out Speaker Johnson again are next to nil. Whatever the House

gins up must get through the Senate with its restrained appetite for huge spending cuts. Meanwhile, the current debt limit suspension expires at the end of January at which time the government either defaults or figures a way to raise or suspend the borrowing limit again. This will be one of the first big tests in the new Congress.

The top priority emerging from House-Senate leadership discussions is the prospect of passing a reconciliation bill to jumpstart the new Administration's agenda. The reconciliation process allows the Senate to pass bills by a simple majority thus avoiding the threat of a filibuster which requires 60 votes to overcome. It is a way for Congress to enact legislation on taxes, spending and the debt limit by simple majority after the House and Senate agree to spending and revenue targets for various committees, called a budget resolution. Once the committees complete their work, a single Omnibus bill is passed by both chambers, and signed by the President into law. This mammoth bill will be used to increase the debt limit, extend the 2017 Trump tax cuts (with some possible amendments such as increasing or eliminating the State and Local Tax (SALT) deduction cap), cut federal spending and impose a wide-ranging immigration crackdown. It remains to be seen in this first month of the second Trump presidency whether the Trifecta control of both chambers of Congress and the presidency will yield such ambitious results.

“The Talk” - Part 2: Heirs Seeking Information on Parents’ Estate Plan

If your parents haven’t shared their estate plan with you, you are being left in a very difficult situation. For children of military families, starting a conversation about finances and inheritance can feel especially daunting. However, these discussions are essential for understanding military benefits and ensuring plans are in place for the future. Addressing these issues early can prevent confusion or legal challenges later.

Why This Conversation is Crucial

- **Preparedness:** Military families often have access to specific benefits like the Survivor Benefit Plan (SBP), Veterans Affairs (VA) benefits, military pensions, and TRICARE. These benefits have various conditions and processes. Without a clear understanding, important entitlements could be missed, or family members could face unnecessary delays in accessing funds. Having parents’ input and guidance on these issues is immensely helpful.
- **Understanding Your Parents’ Wishes:** Your parents may have made specific decisions about their estate or inheritance that need to be communicated. Military pensions, retirement pay, and disability benefits may have certain restrictions or implications that affect how assets are distributed. Understanding these choices now can prevent unpleasant surprises later. A key issue in this area is the difference between “equal treatment of heirs” and “equitable treatment”. When heirs have disparate life circumstances, treating them “equally” (say a 50/50 split of assets) may result in one heir being much better off overall than the other when the intent may have been to have each end up being in about the same overall life situation. Having the parents’ input, while they’re alive, is key to avoiding distress among the heirs.
- **Planning for Long-Term Care:** Discussing long-term care plans is crucial. Whether your parents are still on active duty, retired, or widowed, knowing what resources are available for future healthcare or assisted living ensures they receive the care they need when they need it.

Overcoming Resistance and Barriers

Many parents in military families may resist talking about financial matters. Discussing finances can feel like a loss of control, especially for those accustomed to the discipline and independence of military life. Parents might also avoid these conversations due to discomfort facing their mortality or potential future dependency.

Privacy concerns can also be a factor. Some parents worry that sharing financial details will lead to misunderstandings or pressures from their children. In military families, where privacy and respect for authority are often emphasized, this hesitation can be even stronger.

How to Approach the Conversation

- **Approach with Care and Respect:** Emphasize that your goal is to be prepared in case of an emergency. Frame the

discussion as an effort to ensure everything is in place to support your parents when necessary.

- **Start with General Questions:** Asking about their wishes for the future can open the door to more specific discussions about financial and inheritance planning.
- **Consider Professional Help:** Involving a third-party professional, like an estate planner or financial advisor specializing in military benefits, can make the process easier. A neutral expert can help clarify complex benefits and ease any tension around the conversation.

Starting these discussions now will give your family peace of mind, ensuring that military benefits and financial plans are fully understood and responsibly managed when the time comes.



Help Students Fight Inflation with Scholarships in 2025

February 2025 marks the second month of our annual six-month MOAACC Scholarship Corporation campaign for eligible candidates which culminates in the 42nd Annual Scholarship Awards Luncheon this summer. In 2024, we awarded 11 scholarships of \$7,000. Our July awards presentation provided an excellent opportunity for our scholarship winners, donors and MOAACC members to honor the awardees with some well-deserved pomp and circumstance.

According to *U.S. News & World Report*, for the 2024-2025 school year, the average annual cost of college varied from \$11,011 for in-state tuition; \$24,513 for out-of-state tuition; and \$43,505 for a private college. This reflects a 5.5% increase for private colleges over the 2023-2024 school year, and a 2.2% and 2.4% increase for in state and out-of-state public colleges respectively. A MOAACC scholarship will go a long way in helping awardees pay for the burgeoning cost of college academics and extracurricular pursuits.

Patrick Space Force Base, FL Suspends Trusted Traveler Program

Effective immediately, the Trusted Traveler program has been suspended at Patrick SFB and Cape Canaveral Space Force Station, Florida, until further notice.

The program allowed valid cardholders with escort authority to vouch for people riding in the same vehicle with them without having to obtain pre-clearance approvals. For installation visitors, the program's suspension means that drivers with certain types of DoD ID cards are no longer able to vouch for all passengers in their vehicle.

- Everyone 16 years of age or older will need to show a DoD or military ID card or obtain a [visitor's pass](#).
- Members in housing who currently have family members visiting will be required to get visitor passes and all new visitors will require passes.
- Golfers with an annual base pass can no longer bring or sponsor additional visitors.
- Food delivery drivers without base access will not be authorized base access. All food deliveries will be picked up at the East Gate.
- Event Bright tickets for launches will be terminated.
- Disabled veterans who have a CCSFS and/or PSFB registered Veteran Health Identification Card will be permitted access to the installation.
- Employees with a Defense Biometric Identification Data System registered badge for CCSFS and/or PSFB will be permitted access to the installation.

This U.S. Northern Command directive to suspend this program was taken out of an abundance of caution to ensure the safety and security of our personnel, residents, and visitors. Visitors accessing the base are advised to be prepared for additional screening protocols. There are currently no known threats to the installations.

Great Competition among JROTC Air Rifle Teams

Starting in mid-December 2024 all 14 JROTC programs, regardless of branch of service affiliation, began county and district wide Air Rifle Shooting Competitions. The first Invitational Tournament was hosted at Palm Bay Magnet High School and its Marine JROTC Unit led by SgtMaj Roy DeYoung, USMC, Ret. Nine schools showed up just before the Christmas Holidays to compete.

This year the USAF and USSF JROTC programs are also staging service centric Rifle Meets with GDF again covering the trophies. In early February at least 10 of the JROTC programs are expected to come together for a unique and fun event, called "Run and Shoot" at Veterans Memorial Park. The cadets must run one mile with ruck and rifle, they are then scored and timed for target shooting outdoors using hay bales.

Each winter most of Brevard's 14 High School JROTC programs compete in Air Rifle Marksmanship Competition among themselves and in some cases far beyond our county. Among the best of the JROTC Rifle Teams has been for many years the Palm Bay Jr/Sr Magnet High School Marine JROTC Cadets. On 10-11 January they hosted the Commanders Cup Championship Meet with Army, Air Force, Space Force and even a couple of other county schools attending.

Palm Bay is home to the best Indoor Rifle Range Building in the area which was built on 2022-23 using a special BPS and State grant. MOAACC Good Deeds Foundation (GDF) provided funding in 2023-24 for targets and other equipment on two of the ten lanes and covers the costs of all medals, ribbons, and trophies for all JROTC Rifle meets at any school. Most schools use their cafeterias to set up ranges, but Rockledge also has a stand-alone room for the Rifle Team for which also funded by GDF with \$1000 in 2023 to resurface the 60-year-old floor!!

Other schools have been working hard to field good rifle teams and improve their own facilities to help them do so. Most have to borrow cafeteria or other space on the weekends to practice, but Rockledge and Heritage JROTC programs also got help recently to refurbish their existing ranges. Rockledge resurfaced the 1961 floor of what was then the old Cocoa High School and Heritage is upgrading their targets and other equipment as well.

At least five Brevard JROTC Air Rifle Teams are expected to qualify for the State championships coming up soon, but most will be chasing Palm Bay. Led by two teams of four made up of mostly sharpshooting female cadets, Palm Bay has completed state qualifications and will shoot for the Marine JROTC National title in Anniston, AL in mid-February. They are currently ranked 3rd in the region and 11th among the Marine units in the entire nation.

Perhaps most surprising is the rapid improvement of the Space Force JROTC Rifle Teams at Space Coast High School. They have upgraded targets and their facility with donations which have helped them excel this year. As a result, SCHS JROTC Rifle Teams have qualified for the State USAF Air Rifle Championship in late January and the National USAF JROTC Championship in Mid-February.

JROTC programs raise funds for such teams from many sources including car washes, parent groups, and others. The Good Deeds Foundation of the MOAA Cape Canaveral Chapter is among their largest donors with over an average of \$4500 per school in the 2024-25 school year. GDF also supported floor resurfacing at target upgrades at four schools this year.

Continued success to all JROTC Air Rifle teams as the community continues to support one of the best JROTC programs in the State and, perhaps, the country. Thanks to all JROTC Instructors and schools for supporting our youth enrolled in JROTC which now averages close to 150 students in all 14 high schools.



Honoring the 39th President of the United States

Dr. Jane Hodges had the opportunity to honor our late President Jimmy Carter at the Carter Center in Atlanta on January 7, 2025. The moving tribute to actually share a moment of silence with his flag draped casket will be a moment she will never forget. As a Docent at the Carter Center, an Emory Law School alumnus, and former Georgia state employee, Dr. Hodges often interacted with President Carter. She followed his career since his presidential days when she first met him to her last interaction at his 96th birthday party. Dr. Hodges followed the Atlanta events, TV coverage in Washington DC, culminating to his final resting place in Plains. She spent the last day of the six-day tributes at the Plains High School Museum and visiting historical sites of the Carters. Jane remembers “Jimmy”, as he asked to be addressed, as an honorable Christian humanitarian, who left the world a better place. As a true partner with his wife of 77 years, Roselynn also advocated for children’s rights, when Jane worked at the Georgia Department of Education, where she had the opportunity to work with this amazing woman. Jane also recalls the moment she paid tribute to Roselynn as her casket lay in repose at the Carter Center. President Carter often spoke at the Carter Center and Emory, where he was a visiting professor, and Jane had the opportunity to hear him share his humanitarian work. Most notably was the eradication of Guinea Worm and the tremendous work he did in Nigeria, where Jane volunteered for a year in the villages of the Niger Delta. He will also be remembered for his post presidency work as a true American hero. Rest in Peace Jimmy and Roselynn.

The 242nd Commemoration of
**The Last Naval Battle
of the Revolutionary War**

The Last Naval Battle of the Revolutionary War took place off the Florida Coast, south of Cape Canaveral on March 10, 1783.

The fight began when three British ships sighted two Continental Navy ships, the Alliance commanded by Captain John Barry and the Duc De Lauzun commanded by Captain John Green sailing northward along the east coast of Florida. The Alliance, a 36-gun frigate and the Duc De Lauzun, a 20-gun ship, were loaded with 72,000 Spanish silver dollars they were bringing from Havana, Cuba to Philadelphia to support the Continental Army. One of the British ships, the HMS Sybil, a 28-gun frigate, commanded by Captain James Vashon, chased the Alliance and the Duc De Lauzun to the south. The HMS Sybil fired first, exchanging shots with the slower Duc De Lauzun. Then in a daring strategy Captain John Barry, aboard the Alliance, reversed course, and while under fire, positioned his ship between the HMS Sybil and Duc De Lauzun. When the Alliance was alongside the Sybil and within 1/2 pistol range the Alliance returned fire with a greater number of canon. The battle lasted less than an hour, with the HMS Sybil, outgunned and badly damaged, broke off from the battle and fled. The Alliance and Duc De Lauzun continued on their mission at dawn on March 11, 1783.


