## How Much Do You Remember About July 4th?

We celebrate July 4th as America's Holiday. In school we learned The Second Continental Congress adopted the Declaration of Independence on July 4th, 1776. The 13 Colonies declared their independence from England. But adopting the Declaration of Independence wasn't the only important historic event that took place on a July 4th. How many of you remember these events that all happened on or around a 4th of July?

- 1. Thomas Jefferson, John Adams, and James Monroe, the 2nd, 3rd, and 4th U.S. presidents all died on a 4th of July. In fact Jefferson and Adams both died on Jul 4, 1826.
- 2. The United States Military Academy at West Point officially opened on Jul 4th 1802.
- 3. The Louisiana Purchase was announced on Jul 4, 1803 for \$15M for land west of the Mississippi River.
- 4. The 3-day battle of Gettysburg (Jul 1-3, 1863) claimed the lives of more than 50,000 men making it the deadliest battle of the Civil War. It's often described as the War's turning point.
- 5. The Statue of Liberty was presented to the United States by France on Jul 4, 1884. It stands as a commemoration of the friendship between our counties and has become the welcoming symbol for millions of immigrants who came to America seeking a new life.
- 6. On Jul 4, 1960 the 50th Star was added to the American Flag representing Hawaii, our 50th State.
- 7. The NASA Mars Pathfinder was the first stationary lander and rover to go beyond the Moon and landed on Mars on Jul 4th, 1997. Its mission was to analyze the Red Planet's atmosphere, climate, and geology. It demonstrated a low-cost way to explore the planet. The Pathfinder cost \$265M.

During your 4th of July celebrations see how many of your guests remember these events that happened on a 4th of July. As you celebrate the 4th of July don't forget MOAACC members and families will be participating in the Brevard County Sheriff's 4th of July parade. It starts at 10:00 A.M at Merritt Island High School and ends to Edgewood Jr/Sr High School. Come out and join them.

## **LEGISLATIVE AFFAIRS**

### The National DEBT—Economics or Politics?

The national debt seems to be a prominent topic these days and has prompted Members of Congress on both sides of the aisle to vote in various ways over time. In our case, it has motivated our two US Senators and Congressman Posey to generally vote "No" on any bill that adds to the annual deficit and, thence, the national debt. What appears to be an economic problem is actually a political problem and one that invokes the necessity to have a proper perspective in understanding it.

First, the current \$34 Trillion national debt looks like a large number until it is viewed in a historical and international context. Interestingly, unlike individuals, governments never have to pay off their debt. For example, the debt from World War II never paid off, but as a percentage of GDP, it is markedly lower, thanks to growth and inflation. Next, to stabilize debt as a percentage of GDP for the next 30 years, the Congressional Budget Office (CBO) estimates that we would need to increase taxes or cut spending by 2.1 percent of GDP. Even this isn't a big number because America collects a much smaller percentage of its GDP in taxes than most other rich countries; collecting an extra two percentage points would still leave us a low-tax nation and would unlikely hurt the economy. Stabilizing debt seems hard because our deeply divided politics makes even modest steps toward responsibility extremely hard to take.

To be serious about the national debt, Congress would address it with several simple steps in the near term and take the difficult steps in the coming years. It goes without saying that wasteful or frivolous government spending should be halted and that our defense budget is woefully inadequate. Beyond that, permanently extending the 2017 Trump era tax cuts, most of which are scheduled to expire after 2025, would substantially worsen the fiscal outlook. Such a balanced approach to spending and revenue generation seems to make sense, along with continuing to adequately fund the Internal Revenue Service so that it can crack down on tax cheats.

The Social Security Trust Fund reported in May that unless action was taken, benefit cuts of roughly 20 percent will start in 2033 under current law. At the same time, entitlements (Social Security and Medicare) are producing deficits that just added \$1 Trillion to the national debt in eight months. If Congress did nothing to fix Social Security, we would still get most of your promised benefits because most of the money financing Social Security comes from the payroll taxes being paid regularly by working people. Income from the system's trust funds, which are dwindling, supplements it.

Fixing Social Security is no big deal with an increase in the 12.4 percent Social Security payroll tax of 3.5 percentage points — half borne by employers and half by employees. Such a tax increase for Social Security will never be a popular move. More repugnant is the prospect of cutting benefits, which ought to be ruled out because the overall picture of retirement readiness is dismal with

only about half the workers in the United States covered by any retirement plan aside from Social Security. In any case, it would be a lot better for everyone if the repair job happened sooner rather than later.

Social Security received its last major overhaul in 1983 when Congress and President Reagan ultimately agreed on a few key changes. These included increasing payroll taxes to their current rate, cutting benefits in subtle ways and building a surplus in the trust fund. But that fix relied on assumptions that have not played out. Specifically, income inequality in the United States rose far more rapidly than economists predicted. In 1983, the Social Security payroll tax was imposed on 90 percent of the country's wage income. Today with taxable wages capped at \$168,600, only about 82.5 percent of the nation's wage income is taxed for Social Security. If the cap were raised above \$300,000 to get us back to the 90 percent coverage, the 3.5-percent tax increase needed to fully fund Social Security would be as little as 2.45 percent. Freezing cost-of-living adjustments temporarily might prevent the system's finances from getting out of whack again. The key is the payroll tax which provides the bulk of Social Security's funding.

It all matters to us, or at least it should, because the national debt is intimately connected to how we, the people, view what the Nation spends on Defense, collects in taxes, and keeps its promises embedded in Social Security and Medicare. These are our meat and potato issues. America, with its huge economy and relatively low taxes, isn't facing a fundamental problem of fiscal sustainability. Given the political will, we could resolve debt concerns quite easily. It is time to return to the bipartisan spirit of Social Security reform.

The result is you will build confidence that your Estate Management Plan will improve those you leave behind!!!

## Stress Testing Your Estate Plan - Part 2

Well, how did your stress testing go last month? Did you give yourself a passing grade in both scenarios? Be honest because success in Part 2 depends on taking, and passing, your Part 1 tests.

To recap, your mission last month was to stress test your estate plan in two scenarios: Scenario 1 was you dying; Scenario 2 was your spouse dying. In each scenario you were tasked to imagine the unimaginable, that you are now alone and need to execute the estate plan. Were you able to find all the key documents, accounts, and access information? Were you able to access your spouse's phone and computer? Did you find the keys to your safety deposit box? Did you check what was in the box? Was your contact list up to date? Email passwords? Did you refamiliarize yourself with all the documents, and properly archive them so they are accessible when needed?

We hope so. Now, on to Part 2.

This time, you're both dead, dying in the same accident. How you, working together, prepared for this scenario really does affect how you both will be remembered and honored. Think this won't happen? If you think there's yet another option, okay, but do you have a plan for that option? Remember, not having a plan is not an option. There is always a plan. Your state's intestate succession laws are the state's plan to decide where your money goes. And how much of it will go to them.

Most likely, it will not be practical to have your trustee/ executor run around your home to find everything they'll need. But do they even know that your estate plan exists? Do they know where to find it? Have you shared with them what they need to know to be able to carry out your directions in the plan? Did you explain your rationale and hopes and intentions about bequests and inheritances, if not beforehand, at least in your estate plan? Assuming yesses so far, have you made provisions for them to have access to everything that you found in the Part 1 exercises?

Don't put this off because you don't want to share with them how you divided your assets or how much money they will (or will not) inherit. There is no legal or even moral requirement to do so.

Bottom line: you want control over what happens next. By having a plan, ready to be executed, you control who gets what and when/how they get it. And you make sure that *the state* is not part of your inheritance plan. Your reputation is on the line, even after you're gone.

In future articles we'll discuss "the talk" that your heirs want to have with you.

## **POINTS TO PONDER**

This July 4th we celebrate the 248th birthday of our nation. We owe much to the character of those who made us a free people, enjoying the blessings of liberty to this day. Many of the founding fathers were God-fearing, faith-filled soldiers, scholars, statesmen and clergy. We recount their words and deeds that launched a republic...

On June 7, Richard Henry Lee (VA) proposed that the Continental Congress make a declaration of independence from the British crown. John Adams (MA) seconded the proposal. While the representatives went home to determine the will of their people, Adams, Jefferson (VA), Franklin (PA), Livingston (NY), and Sherman (CT) drafted the declaration, including: "The separate and equal station to which the Laws of Nature and of Nature's God entitle them...all men are endowed by their Creator with certain unalienable Rights... appealing to the Supreme Judge of the world for the rectitude of our intentions...for the support of this Declaration, with a firm reliance on the protection of divine Providence..."

As Congress debated, Adams rose with great conviction: "Before God, I believe the hour has come. My judgment approves this measure, and my whole heart is in it...live or die, survive or perish, I am for the Declaration. It is my living sentiment, and by the blessing of God it shall be my dying sentiment!"

Two late arrivals determined the outcome of the vote. One was Presbyterian Minister John Witherspoon (NJ) who announced on behalf of his delegation, "In our judgment, the country is not only ripe for independence, but we are in danger of becoming rotten for the want of it…". Caesar Rodney (DE), ill with a facial cancer, was half-carried into the hall in Philadelphia; he barely uttered, "I vote for independence!" The vote was unanimous, and in that moment the Thirteen Colonies became the United States of America.

At the signing, and as the delegates pledged their lives, their fortunes and their sacred honor, Sam Adams (MA) rose to declare: "We have this day restored the Sovereign, to Whom alone men ought to be obedient. He reigns in heaven and... from the rising to the setting sun, may His Kingdom come."

To which, all who treasure the life we as Americans have been given add a resounding, "AMEN!"



## Countdown to a Major VMC Park Upgrade

In early August the Brevard County Commissioners are scheduled to meet and finally approved the largest upgrade ever to Brevard's Veteran Memorial Center 82-acre Park. Funds from the State, County and Tourist Development Council now total over \$8M and are in place for the final decision to build a major amphitheater with more restrooms and picnic buildings, electrical upgrades, lighting, irrigation and major additional tree and shrub plantings.

The project was first laid out and approved in part in 2019, but covid and cost increases created delays which hopefully will end in August with a ribbon cutting soon after. Ivey's Construction, which built our museum in 2015-16 as well as Phase I of the Park, is the primary contractor and has a fantastic record of finishing on time and on budget, so we are hopeful by Memorial Day of 2025 all will be ready.



## Brevard Refuses to Forget One Veteran

On 01 June a Memorial Service was held to honor and remember an Army veteran of the Vietnam Era. The story of what brought about 60 people together for that service at Christ Central Church in Cocoa was amazing.

Howard Richard Browning was born in Ohio just before WWII began. He died, with no next of kin on hand or available to claim his remains, on the 4th of July 2023. Browning joined the Army in 1963 and served in the Ohio Army National Guard until 1969. He then served for more than 35 years in the US Postal Service before retiring first to North Carolina and finally to Brevard County alone about 8 years ago.

Just about a week before Browning died, US Army veteran, retired Brevard law enforcement Officer and now Chaplain David Rodriguez met him by happenstance at Ruby Tuesdays. Browning by then was in a walker and eating alone a few tables away from Rodriguez. A short conversational exchange led to sitting down together and learning Browning had also served in the Army. Plans to meet again were made and a photo taken. Months passed and Browning did not reach out. Rodriguez decided to do some research on the internet and eventually came across the funeral notice, posted days after the meeting.

He was moved to action. He and Pastor Tim Kroll reached out and

eventually the funeral home confirmed there were no immediate next of kin but there was a phone number of a step daughter in North Carolina. Under US laws the funeral home could not pass that contact information, but promised to let Karen Connell know about Rodriguez. She gave approval to the home this spring to release the remains of Browning to Pastor Kroll. He and Rodriguez were about to arrange at their cost internment at a local private cemetery with a veteran's section when they learned about Brevard No One Veteran Left Behind (BNOVLB). BNOVLB is a county wide program sponsored but the VMC, MOAACC and the Support Committee of the CCNC.

Donn Weaver of BNOVLB met them at the Veterans Memorial Center Library in late May to hear the amazing story and provided a veteran hand carved urn for Brownings Ashes. He attended the service along with some neighbors, Combat Vets and other veteran motorcycle group members and others from the church. Thus, Browning's Celebration of Life had many to serve real witness. Only three people who attended said they had ever met Browning. His step daughter was too ill to travel but watched on zoom and shared her story when Browning married her mother and she was a rebellious teenager at that time.

This story, hopefully, will end in late September 2024, when BNOVLB plans to include Browning with other veterans not claimed by families in a special service at the Cape Canaveral National Cemetery to try to insure no one vet is left behind.

On 13 June, Vice President of Good Deeds, Mike Gautreaux and his wife Phyllis and President Donn Weaver drove to Jacksonville, FL to accept a major Award Grant of \$20,000 from the VyStar Credit Union Foundation. While 12 awards worth over \$200,000 for Florida and Georgia winners were given out at the VyStar downtown Headquarters building, only GDF and the Jacksonville Navy League received funds for veteran organizations.

## Vets Back to Class - Year in Review



It was another outstanding year for BPS' Vets Back to Class (VBC) program. During the 2023/2024 School Year, VBC had the opportunity to speak with 4,250 students in twelve different schools across the county.

Developed in 2015, the VBC program was created by MOAACC and the Veterans' Memorial Center (VMC) to provide educational outreach to the students of Brevard County. Over the course of nine years, the program has grown, evolved, and proven its value by educating kids of all ages in public, private and home school settings on topics ranging from the creation of our Constitution to the World Wars and War in Afghanistan. Veteran volunteers have donated their time and experience throughout the years, bringing a personal touch to history and military education by coming into the classroom setting to teach about these important

subjects. During their presentations, these veterans discuss not only the history of our Nation, but their own personal history, with a focus on how being a Veteran has impacted their life. Oftentimes, they bring with them combat era trunks filled with actual artifacts that help to bring history to life for students. During the pandemic, the group got creative and filmed 18 Veterans covering key topics of value for our school systems. The video resources and other tools offered by VBC are always available online for teachers at BPS and other school systems.

While the number of Veteran Volunteers ebbs and flows from year to year, the program itself continues to grow. During the 2023/2024 school year, VBC added STEM related programs including five special science fairs for BPS students at the VMC. In addition to the science fairs, veteran volunteer lectures, educational videos, and historical trunks of artifacts, the VBC also facilitated 14 school field trips to the VMC to further bolster students' knowledge of their Country's history. Furthermore, the Education and Citizenship Armed Forces Coalition of the Space Coast (ECAC), was developed this year in partnership with MOAACC, VMC, BPS, and other military and Department of

Defense (DoD) entities to bring additional education and career opportunities to students in Brevard County. In August, ECAC will be taking full effect with BPS. Over the summer, VBC is encouraging students and their families to check out local museums like the VMC, the Liberty Bell Museum, and more, to gain a better understanding of the rich history of Brevard County.

The VBC Program offers links to teachers where they can describe their classroom needs for these historical presentations. By offering a personal connection to the materials being learned, students will come away with a more intimate understanding of the history of our Nation and the men and women who helped to shape it and pave the way for others.

## The Role of Aircraft in WWI (Part 6)

THE LAFAYETTE ESCADRILLE. Hundreds of Americans traveled to France in a quest to join the famed squadron. Unable to accommodate the flood of volunteers within the original unit, French Air Service leaders formed the Lafayette Flying Corps, in an effort that saw more than two hundred American volunteers join a variety of French squadrons. Their contribution to the war was undeniable, with the volunteers shooting down 199 German aircraft.

These were the trailblazers of a significant shift in the West. America's unparalleled effort, a historical achievement, evolved into a monumental crusade. Every eligible man enlisted under the Stars and Stripes, not for personal gain or world dominance, but for the noble ideals that formed the bedrock of civilization. The nation's entire resources were wholeheartedly committed to securing victory.

When the United States entered the Great War in 1917, the pioneering airmen of the Lafayette Escadrille laid the foundation for American combat aviation. Clad in United States Air Service uniforms, these seasoned flyers continued to fly and fight, sharing their combat aviation expertise with their newly arrived counterparts. This ongoing service was pivotal, with American airpower playing a decisive role in a series of battles that ultimately led to the Allied victory in November 1918.

The men of the Lafayette Escadrille came to France's aid at the height of the First World War, when the debilitating cost of attrition warfare threatened to push Allied nations to the brink. With vast trench-bound armies locked in a bloody stalemate, commanders sought to harness the air domain as a new front to secure victory.

With no nation possessing a monopoly on the aerial province, leaders had to consider how to counter hostile forms of airpower. Initially, airmen improvised by taking rifles and pistols with them on their patrols. Aerial duels erupted above the trench lines as opposing flyers spontaneously fired at one another. This approach was eventually superseded when aircraft designers devised methods of installing fixed machine guns in their latest designs. (Next month: The Role Of Aircraft In WWI. Part 7)

## Celebrating Women Veterans


